Dear friends and supporters of Caritas Slovakia,

with a feeling of gratitude and responsibility, we present you this annual report on how the Caritas Slovakia, together with ten diocesan caritas fulfilled its mission of "being close to people". In Slovakia, we helped people in need mainly through a wide network of professional social, medical and other services, and facilities of diocesan caritas, but also thank you to the hundreds of volunteers associated mainly in the growing network of parish caritas. Attached statistics confirm Caritas is in the position of the largest non-public provider of social services in Slovakia with the widest range of services for people in need from the first to the last days of their lives. We also continued to provide specialized assistance to victims of trafficking, highlighted problems of migrants and refugees, and persistently brought the voice and needs of the poor into public debates and law-making.

Last year, by mutual agreement, we handed over fourteen Charity Houses to the Conference of Senior Religious Superiors of Slovakia. We remain connected with the nuns at rest after more than thirty years together in mutual prayers and memories.

We also continued our assistance in the Middle East and other poor countries of the world, especially in sub-Saharan Africa. The Children Adoption project and Lenten Box for Africa brought thousands of children hope and chance for a better life, as well as support from the Bishops Conference of Slovakia and The Ministry of Foreign and European Affairs brought help to refugees and persecuted Christians. We are also pleased that we have been able to extend assistance to our neighbors in Ukraine to include direct assistance to people affected by the war.

Unfortunately, the word pandemic cannot be left out in the 2020 annual report. However, it will always be associated with the dedicated work of employees and front-line volunteers in protecting lives and health of clients in our caritas facilities. It will also be associated with sewing facemasks and food and material aid distribution to dependent individuals and entire communities in Slovakia, but also with food and hygiene packages for the needy in Uganda, Rwanda, Iraq, and other countries. The pandemic will therefore be linked in our memories with admiration for a huge wave of solidarity between individuals and organizations.

In 2020, we had the opportunity to experience that "Our heart beats for caritas" and therefore respond to the challenges we faced. We are grateful for being able to help people in need to survive yet another year together with you.

Beloved brothers and sisters,

I would like to greet you all in the service of Caritas Slovakia and arci/diocesan caritas in this annual report for 2020. I am speaking to you for the first time.

First, I want to thank my predecessor, Mons. Štefan Sečka, who was the president of Caritas Slovakia for several years, and last year the Lord called him to eternity.

Last year was also marked by a coronavirus pandemic. Nevertheless, all of you who have shown in "Our heart beats for Caritas" extraordinary commitment in the service of your beloved ones, in the service of Jesus Christ, who identifies himself with every "little one."

Yet Christ clearly says, "You did for me" (Mt 25:40). He himself experiences love in every individual, he receives help without difference to any sufferer. He himself is present in the one who is suffering, because his suffering has spread to every human suffering.

Caritas is presented in the very important Council document *Lumen gentium as an essential and fundamental dimension of the life of the Church* (cf. On this organic and unified basis, the pastoral plans, structures and means by which the caritas can fulfill its mission. Christianity without caritas would not be complete. The essence of Christianity includes concrete love of loved ones.

Saint Pope John Paul II. in the social encyclical Centesimus annus states: "The Church, faithful to the command of Christ, her founder, is always in this field present to provide material support to the needy person, which does not humiliate him or make him or her the object of care, but it helps him get out of a difficult position by promoting his human dignity.

With great gratitude to God, we must point out that this charitable activity in the Church has never been extinguished and today is recorded as multifaceted and encouraging boom.

In this context, the phenomenon of voluntary merits special mention services to which the Church tends and supports him by encouraging cooperation all to assist and encourage him in his initiatives.

To overcome today's widespread individualistic way of thinking a concrete effort of solidarity and love is needed. It starts in a family where you are married, you help each other, and generations take care of each other. This is how the family becomes a community of work and solidarity" (CA, 48-49).

Farewell to the nuns from the charity houses

From March 1, 2020, the administration of the elderly's charity houses has been passed on. Caritas Slovakia said official goodbye on February 18 at the meeting of the Council in the Spiš Capitola, thanked to the nuns for their dedicated work and prayers and wished much of God's grace into the years to come. We continue to be in touch with the nuns thanks to the stories of the individuals that we document in cooperation with the organization called Post Bellum SK.



Caritas Slovakia and dm drogerie markt helped children in need for the 9th time in a row

Overall, we supported this year a total of 151 families, of which 43 were nominated by dm drogerie markt employees and the remaining families were added in nominations from Caritas Slovakia. Each of them received annual supply of diapers in the form of 32 vouchers; one voucher entitled them to one package of diapers their own choice.



Profesia Days

Already the 11th year of the largest festival of job opportunities in Slovakia Profesia days took place on 4 and 5 March 2020 and we could not miss it. We convinced the visitors of our booth that dream colleague can also be a volunteer while serving them an excellent coffee from the award-winning company. We were pleased that more and more socially responsible companies which care of the good of society and environment have attended.



National Week of Caritas continued on a wave of solidarity

From 30th May to June 6th, we organized 3rd annual National Week of Caritas which took place online in cooperation with 10 archdiocesan and diocesan caritas to present charitable services and facilities in all regions of Slovakia. The situation did not allow the event to take place, however, we took advantage of the online space and proved the audience with 5 discussions ranging interesting topics resonating in society.



Caritas Slovakia has a new president

Bishop Mons. Tomas Galis has been elected for five years from 12th November. Bishop Tomáš Galis completed his theological studies at Faculty of Theology in Bratislava in June 1976, when he also received the diaconal and priestly ordination in the Dome of St. Martin in Bratislava for service in Banskobystrická diocese. In 2008 he was appointed by Pope Benedict XVI. as the diocesan Bishop of Žilina diocese. He has long been involved in the pastoral care of young people and scientific and academic activities. He takes office as the president after the deceased Bishop of Spiš, Mons. Štefan Sečka.





Weekend of Open Parks and Gardens

We were part of the autumn edition of the Weekend of Open Parks and Gardens for the first time. One of the shows featured four religious gardens, which also included our garden - the garden of the canonical house on Kapitulská street. Throughout the event, we have shown the visitors an exhibition of 7 migration myths that originated from the cooperation of the project MIND and the artist Lucie Doms.

Food aid under OP FEAD

V roku 2020 prebehla posledná 15. distribúcia potravinovej pomoci v rámci Operačného programu FEAD, ktorý bol úspešne spustený v r. 2016. K našim spolupracujúcim charitám v rámci Programu patria: ADCH Košice, SpKCH, TACH, BACH, DCH Žilina, DCH Nitra, GrECH Košice, Charita sv. Vincenta Prievidza a Charita sv. Alžbety Zvolen. Distribúcia začínala v marci – práve v čase, keď boli na Slovensku potvrdené prvé prípady koronavírusu a následne vládou vyhlásený núdzový stav. Preto sme výdaj potravinových balíkov a s nimi spojené sociálne opatrenia zabezpečovali za prísnych hygienických opatrení. Koneční a sekundárni príjemcovia boli najodkázalejšie osoby: viacdetné rodiny, seniori s nízkym dôchodkom, ľudia bez domova, ťažko zdravotne postihnutí, ľudia z marginalizovaných skupín, ale aj tí, ktorí zrazu stratili prácu a istý príjem. Aj sprievodné opatrenia sme prispôsobovali epidemiologickej situácii: informácie o sociálnej pomoci a o predchádzaniu nákazy covidom si mohli ľudia prečítať na letáčikoch. Za mnohými z nich sme išli, čo najbližšie k ich príbytkom. Aj tento rok sme pri distribúcii aktívne spolupracovali s mestami a obcami. Do distribúcie bolo zapojených niekoľko desiatok sociálnych pracovníkov a dobrovoľníkov charít.

Development of social services and education

Complementary training for caregivers Train to Care

We have been successfully cooperating with the Caritas Austria for seven years and together we offer quality short - term courses for caregivers. Courses allow you to acquire knowledge, experience, and skills that participants can use for the benefit of themselves and their clients.

We are pleased to be able to organize a popular course in Kinesthetics during pandemic year of 2020, where participants had the opportunity to learn how to mobilize the client while saving their health, and webinar on the topic of coping with workload in 24 hours nursing service, which offered advice and ways to to manage stressful situations in the daily work of carers.



Education of charitable employees

Already in 2019, thanks to the support of Caritas Europa, we started more intensively devote to the training and development of our employees. In 2020, we cooperated with the educational organization D'Atelier which organized a series of four so-called leadership studios for leading employees of the Caritas Slovakia and directors of diocesan and archdiocesan caritas. The aim was to develop skills in leading people and organizations. The meetings took place in a very friendly atmosphere in premises of the Quo Vadis House in Bratislava. In addition to leadership program there was also a training of Nonviolent Communication, under leadership of an experienced lecturer, Mrs. Eva Račková, in a pleasant environment of educational center at Lukový Dvor near Nitra.

As the training and development of employees and people involved in the provision social services is an important part of the activities of Caritas Slovakia, we plan to continue these activities in the future.

STOP Human Trafficking



St. Bakhita - Prayer for victims of trafficking 8.2.2020

The year 2020 was unpredictable and significantly affected the activity of STOP Human trafficking project. The pandemic suspended planned preventive activities of the project and also limited identification and referral of new potential victims who could join the assistance program.

It consists in the **reintegration of victims of trafficking into society** as the main pillar of the project. Caritas Slovakia (SKCH) implements the project in partnership with the Greek Catholic Charity Prešov. In 2020, Caritas took care of 11 new clients (SKCH 6, GKCH 5) and provided care to a total of 21 clients during the year (SKCH 14, GKCH 7). 8 victims were eliminated (SKCH 7, GKCH 1).

Before and during the pandemic, we continued in a limited regime in **pre-return assistance and assisted voluntary returns** of victims of trafficking. This service was much difficult to handle due to lockdowns, recurring boundaries and other anti-pandemic measures.

However, we provided pre-return assistance to **13** Slovak citizens in the United Kingdom (8), Ireland (1), Germany (2), Belgium (1) and Greece (1), of which 6 were women (form exploitation: sexual exploitation, domestic slavery) and 7 men (form of exploitation: forced labor, domestic slavery).

We implemented assisted voluntary return for **4** clients. 3 persons were returned from the United Kingdom, 2 of them have been exploited by forced labor, 1 person sexually, and 1 person was returned from Ireland, where she was exploited for forced labor.

In cooperation with the Ministry of Foreign and European Affairs of Slovak Republic, we also managed to train 20 future consuls which were sent to embassies of the Slovak Republic abroad. The operation of the National Helpline for victims of human trafficking was always ensured. Throughout the year we recorded a total of 354 calls and 159 callers (87 men, 70 women, 2 children). We have dealt with several potential cases of human trafficking, of which 2 victims were identified and subsequently included in the Victim Support and Protection Program of the Ministry of the Interior of the Slovak Republic.

Preventive and educational activities could take place only in very restricted mode. Nevertheless, we managed to implement several discussions in community centers, a children's charity and youth, dormitories for the homeless, provided education for social workers of Alternativa, an independent life center in Banská Bystrica, and also established a new cooperation with Humanitarian Council of Slovakia in preventing human trafficking between foreigners in Slovakia.

Our regular visits to the detention camp in Humenné combined with a preventive discussion on human trafficking and **search potential foreign victims** among asylum seekers and have been paused since the outbreak of the covid pandemic in March 2020. Only 2 discussions took place during the year (January, February) for a total of **9 foreigners** from countries such as Afghanistan, Syria, Vietnam, and Ukraine.

Caritas Slovakia was the guarantor of the nationwide campaign Red Ribbons and a member of the international network RENATE. We also continued our regular meetings of the non-profit platform Civil Society Platform against Human Trafficking in Brussels, which due to the pandemic, took place online.

The annual activity of our project is "St. Bakhita's day", which took place on February 8, when we commemorate the victims of human trafficking. It is International Day of Prayer and awareness of human trafficking, identified by the Pope Francis in 2015 - on the day of the liturgical memory of St. Josephine Bakhita, patron of victims of human trafficking. Prayers were held at the chapel of St. Catherine on Michalska street and was transmitted online via Radio Maria of Slovakia. Each year we invite more and more parishes and communities, as our ambition is to spread the initiative of Pope and to alert the public to persistence slavery and exploitation in modern society.

During the second wave of the pandemic, we established cooperation with the non-profit THE WHY organization, which aims to provide and mediate free access to information for all and the main activity was production and distribution of documentaries on human rights, democracy, justice, and equality. On World Day of slavery, on December 2, a modern campaign was launched to promote awareness and combat this practice. The campaign is based on the belief that pointing out and discussing this issue is in a pandemic time more important. Since screenings in cultural and social centers, schools or other institutions were limited, films dealing with current topics of human trafficking were also made available online for two weeks in multiple languages.

National Helpline for Victims of Human Trafficking - 0800 800 818 operates on weekdays from 8a.m to 8p.m., otherwise through the answering machine. The main partners of the helpline are the Ministry of the Interior of Slovak Republic and Slovak Telekom.

Project MIND

In 2020, the MIND project was in its third, final year of its implementation. Working migrants, their contribution to development society, migration and development were the main themes of the campaign activities aimed at raising awareness of a phenomenon such as migration. The summer campaign on social networks in 2020 lasted 8 weeks, during which dozens of posts highlighted the positive contribution of people who found not only their new one in Slovakia, but also work fulfillment. Due to the pandemic Covid-19 many project activities were moved to an online form, such as a mobile exhibition of sustainable development goals and migration, online quiz, videos and interviews with experts that have had a major impact on the public.

Press trip to Cyprus

The summer season provided several opportunities to get involved in various public events and to implement the third and final press trip in July 2020 to the Republic of Cyprus. Cyprus currently possesses the highest number of refugees per capita among EU countries, Three young journalists were accompanied by Elizabeth Kasshhinis, Executive Director of Caritas Cyprus. The program included a visit to a migration center in Nicosia, shelter for women and shelters for men, meeting with a representative UNHCR in Cyprus, with the Cyprus Refugee Council, a visit Dignity

Center, Kofinou Refugee Camp, visit Larnaca Migration Center. There was also a meeting with two Cypriot journalists.

Advocacy

MIND has significantly contributed to the visibility of advocacy activities within the network of NGOs working with migrants and refugees, as well as promoting positive views on migration in Slovakia. Before the parliamentary elections on 29 February 2020, four briefings took place with political parties. Subsequently, two were elected. A lot of politicians expressed interest in further meetings. Cooperation continued throughout spring and summer. 4 more political briefings, consultations and face-to-face meetings took place in August. Advocacy focused on two main areas: 1) Slovak Republic as a reliable partner in the migration strategy of the EU countries, with which it will cooperate in a spirit of solidarity; and 2) resettlement of unaccompanied minors from the Greek islands to Slovakia.

We have repeatedly called for security and solidarity with refugees and migrants in the EU. MIND has issued several statements of assistance migrants during the coronavirus and the call for refugee resettlement after a catastrophic fire in Camp Moria, Greece.

MIND (Migration. Interconnection. Development) is a three-year project funded by the European Commission, aimed at increasing awareness of migration and sustainable development.

Parish caritas

Caritas Slovakia in cooperation with archdiocesan, diocesan and eparchial caritas successfully continued the project called:

Building capacity to support charitable activities in parishes and communities.

The main donor of the project is Renovabis.

The parish caritas is the third pillar of the church in the parish and is pastoral parish community body whose task is to lead, coordinate, promote and testify love of neighbor by concrete deeds. It is a community of believing parish volunteers who carry out the charitable mission of the Church in the spirit of the Gospel commandments of love.

Volunteers working in their parish charity are people, thanks to whom we can get to a specific person directly in parish that needs help. It is also unique in that the person who found himself in difficult life situation, in material, financial, relational or another need can turn to someone close to him. If the competencies of the parish caritas are not enough, then there are archdiocesan, diocesan, and eparchial caritas that can help a specific person in a targeted way.

The actual implementation of the project takes place in 2 archdiocesan in 3 diocesan charities. Diocesan parish caritas coordinators are professional parish guarantors. Their role is to help establish a parish caritas in parish, animate, coordinate the activities of the parish caritas and shape volunteers.

The activity in 2020 were significantly affected by a pandemic situation during which parish volunteers were in the so-called first line of help.



During the first phase of pandemic, the following activities took place:

Volunteers of parish caritas sewed face masks on a professional level, which were then distributed by the volunteers to different charitable and state social facilities, hospitals, seniors, and marginalized groups. Material for the face masks was also provided by various companies and individuals. We handed out more than 10,000 face masks.



The second successful project during the pandemic was implemented through our caritas in Bratislava so called: **Send a bag** to which was later spread to other diocesan caritas in Slovakia. The aim of the project was to help the elderly and the lonely through volunteers who helped them with a purchase of grocery during the lockdown.

The third project: in cooperation with our long-term donor dm drogerie markt, we provided diaper vouchers to large families in material need. In total we supported 108 families. Every family received an annual supply of diapers in the form of 32 collection vouchers.



"In difficult life situations, all help is welcomed, and that is why we try to help children and their parents in need free of charge providing babylove diapers, "said Janka Poláčková, procurator of dm drogerie markt.

Erich Hulman, Secretary General of Caritas Slovakia adds: "We very much appreciate that even the current crisis has not prevented dm drogerie markt and Caritas Slovakia to continue the much - needed diaper aid project for children. Not only specific material assistance, but also regular contacts with sales staff and charity staff help supported families in their difficult life situation. Thanks to the generosity of our partner, we can be close to a person in need."

During the 2nd lockdown from September - until the end of 2020 the parish caritas volunteers were again in the front line of help and successful involved in many archdiocesan, diocesan aid projects and eparchial caritas through national and local assistance projects:

- Collection of school supplies for children and families in material need
- Continuation of a successful project: **Send the bag**
- food and material assistance to people in need and the marginalized groups
- Tesco collection of durable foods. The collection took place in 153 Tesco stores in Slovakia. 100 tons were collected worth more than 165 thousand euros.
- A festive Christmas meal for people in need that was funded by *Giving Friday*, thanks to the dm drogerie markt initiative. This amount was € 45,105.40, which was later increased by the value of the food in the amount of € 5,000, also donated by dm drogerie markt. Overall, we provided food and gifts to more than 2,500 people in material need.

Project in numbers for 2020:

- 7 archdiocesan, diocesan caritas are involved in the project
- A total of 59 new parishes were registered in the project and concluded in 26 cooperation agreements
- 545 new volunteers were registered, which is roughly 66% increase compared to the original number of volunteers.

Services of Diocesan and Archdiocesan caritas

Caritas Slovakia aids through 10 arch/diocesan caritas. This assistance is provided to the citizens of all ages. Caritas Slovakia is also a member of the Association of nonpublic social service providers and regularly participates in the legislative setting of social services in the Slovak Republic, where it also uses its many years of experience and wide scope. Not only the directors of diocesan and archdiocesan caritas, but also selected employees work in several working groups, whether at the level of the state, or at the level of regions; they are members of umbrella groups and cooperate with other partner organizations.



A. Healthcare services

Within the meaning of Act No 578/2004 Coll. on healthcare providers; in 2020, **214 healthcare service employees** took care of **4,757 clients** in **40 different facilities**.

In pursuant to Act no. 305/2005 Coll. on the social legal protection of children and social guardianship, **77 employees** took care of **442 clients** in **8 facilities**.

The most important area of Caritas Slovakia other services were charity houses for nuns. By agreement with the Conference of Senior Religious Superiors of Slovakia, all **14 charity houses** were handed over to them.

Caritas of Spiš operated **3 shops with religious items – the Caritas bookshop**, as well as the pharmacy. Among other services provided, the most significant are the **3 sheltered workshops** run by Caritas of Spiš, Nitra and Košice. At the same time, Caritas of Prešov published a monthly magazine called Cesta and in Kahan Club took care of people fighting against alcoholism. Caritas of Bratislava run a Center of Solidarity.





Collection of school supplies

From June 1 to September 15, the Collection of School Supplies and electronics took place. It was aimed to help children from socially disadvantaged families, orphanages, and crisis facilities. Although the 11th year of the collection was affected by the situation around pandemic and its economic impacts, we

collected a record number of 55,000 donated school supplies fundraised more than € 7,500. Mayor of Bratislava Matúš Vallo took over the patronage of the collection and other local governments, companies producing school supplies, schools, teachers also helped promote the collection.



Food collection in the TESCO stores


The Tesco food collection has once again helped people in difficult life situations to survive the most beautiful Christmas holidays. Customers could donate durable food from 19 November to 3 December 2020 in all 153 Tesco stores in Slovakia. We managed to

collect 100 tons of food and cosmetics worth more than 165 thousand euros. After the end of the collection, Tesco donated among participating organization additional financial assistance - in the amount of 20% of the value of food and cosmetics collected in shops.

Development cooperation

Our work continued to focus on providing education for socially disadvantaged children and young people in the countries of sub-Saharan Africa. The coronavirus pandemic affected the lives of people all over the world and in a very significant way on the African continent. Children and young people stopped going to school, a lot of people lost their everyday way making money. Our help focused mainly on support most vulnerable families in the form of food aid, medicines and hygiene needs.

Our work in Uganda

Gift of Love Center in the Adjumani district of northern Uganda has been providing comprehensive care for HIV-positive children since 2012. There are also handicraft carpentry and tailoring workshop at the center that provides annual craft education for young people from the area, as well as a kindergarten with a capacity of 120 children.

Due to measures related to the coronavirus pandemic, teaching in kindergarten and in workshops was suspended during the year. Our work focused on mitigating the effects of anti – pandemic measures and specific assistance to the most vulnerable, in particular:

- Field social workers selected the 100 families they received regular food aid. They delivered packages on motorcycles
- For the refugee camp Pagirinya near our center, we have built additional sites for hand washing and purchased disinfectants in collaboration with the Archdiocesan Caritas Gulu. In addition, graduates of tailoring courses sewed a number of face masks that were purchased by refugee organizations such as UNHCR.
- As per request of the local bishop of the diocese of Arua in Uganda, we provided funding for the purchase of food and basic hygienic aids for priests. Due to closed church, the priests did not receive any financial aid from the faithful and without the aid, they found themselves in a very difficult situation. The staff of the center was in a regular contact with the children during its closure and after their return in June 2020 they organized tutoring in smaller groups according to grades.

In February 2020, journalists of RTVS editor Anna Šipošová and cameraman Richard Jančík also visited a charity center in Uganda. Based on their stay, they published several reportages in both tv and radio.

Our work in Rwanda

Cultural Center of St. Vincent Palotti in the pilgrimage town of Kibeho started 2020 in new premises with a capacity of up to 106 children. After the closure of the center, the staff remained in contact with the children and their families through regular visits and distribution food aid. Every family which child goes to our kindergarten, could regularly take away food for all its members and as well as the families of the children who visited the center in the past.

In addition, we financially supported pallotine priests in their purchases of food and hygiene aid for the 395 poorest families in various Pallotine parishes throughout the country.

Development Volunteering

Caritas Slovakia regularly sends volunteers interested in working with children and young people to project sites in Uganda and Rwanda. In 2020, 7 volunteers worked here. The work of 4 of them was terminated prematurely due to the Covid19 pandemic. The costs associated with volunteering were covered from the Lenten Box for Africa and the Slovak Agency for International Development Cooperation (SlovakAid).

For new people interested in volunteering, we have prepared 2 online information webinars attended by almost 50 people. We received a total of 48 applications from all over Slovakia.

Lenten box for Africa 2020

Despite the prematurely closed churches and the impossibility of meeting with donors in parishes, a large number of donations once again portrayed your generosity. The proceeding of the public collection reached EUR 196,301 euros; another 77,718 euros were donated by donors through the online portal called darujme.sk

The proceeding of the collection allows us to implement development projects in Uganda and Rwanda and to engage in long-term assistance to children and young people.

Humanitarian aid

We want to be close to people in need but only at home but also abroad. We help not only during a pandemic, but also in armed conflicts, to help restore cities so the local people do not have to leave their homes. This year, we also helped those who fear they had to leave their homes or found themselves in refugee camps, where they seek temporary shelter.



Children in kindergartens in Syria develop their skills through singing and playing, joy comes into their lives, often hard-pressed from an early age.

Syria

We helped: 600+ people + human intervention online

We managed to: support the kindergarten, family center, cultural institute, training, and counseling center for women

Implementation was possible thanks to: Bishops Conference of Slovakia, individual donors, and a local Syriac Cross partner

Many women have lost husbands because of the conflicts, so we help to set up nurseries that mothers can entrust children as soon as they acquire new skills in a training or counseling center. They are trained as hairdressers, beauticians, and thus get a chance to earn a living for their families. The total amount of aid is **EUR 93.700**.

Lebanon

We helped: 20 children with their families + help after explosion

Implementation was possible thanks to: Bishops Conference of Slovakia, individual donors and the Order of the Little Sisters of Nazareth in Lebanon

We continue to support studies for 20 Palestinian children in the Dbayeh refugee camp. Many families in the camp do not have the money to pay children's tuition and provide transportation to the school. Our help precedes creation of the so-called lost generation that was in childhood due to war reduced by the opportunity to learn. In August 2020, eruption in the port of Beirut hit the already economically swept country which resulted in it about home 300 thousand people injured. It was announced that we were going to help the people affected by the blast by organizing collection. Through a joint effort, financial assistance was sent to Lebanon in the amount of **EUR 27,097**.



Thanks to support from Slovakia, the children of Palestinian refugees living in a refugee camp can also study in Lebanon.



Tetyane also got help in Ukraine and fled the riots to Donetsk with two children, one son being disabled.

Ukraine

We helped: the overall goal is to help 600 families

Project: Material and psychosocial support for internal displaced

persons in the Dnipro region

Aid worth: EUR 100,000

Implementation was possible thanks to: co-financing from the Slovak Agency for International Development Cooperation (SlovakAid), financial support through Children's adoption project, individual donors, and local partners Caritas Donetsk

In November 2020, we launched a project aimed at helping families, who had to leave their homes due to the armed conflict on the border with Russia and seek shelter in another part of the country. Many survived, were left without homes. We organize psychosocial trainings for them with a local charity and we distribute food and medicine vouchers to the neediest ones. The project was supported by a voucher donation campaign. The project will end in October 2021.

Iraq

We helped: 35,470+ people

We managed to: complete 2 wells and start construction of another 3 wells, ensure the installation of water filters and solar panels, support construction of crèches and nurseries, build a common room, adjust library

Implementation was possible thanks to: Slovak Agency for International Development Cooperation (SlovakAid), Bishops Conference of Slovakia and local partner: Shingala Azad, Chaldean Catholic parish of St. Joseph and the Religious Community Khalil

In a country marked by combat operations Daesh (so - called Islamic state) ongoing since 2014, we help to renew infrastructure and provide access to drinking water. Thanks to the project we managed to complete the construction of 2 wells in the municipalities of Bashik and Bahzani worth EUR 216 468.95 and start with the construction of another 3 wells, which will be completed in 2021.

In cooperation with Bishop Conference of Slovakia, we were able to support the persecuted Christians in Suleymania, Iraq and help this hard-fought community. The amount of aid sent was **EUR 160.350.**


Who is the help for?

Vision and mission of the project







INDEPENDENT AUDITOR'S REPORT

To the Supervisory Board and to the General secretary of Slovak Catholic Charity Regis. No. 00 179 132

Opinion

We have audited the financial statements of Slovak catholic charity, which comprise the balance sheet as at 31 December 2020, and the income statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Entity as at 31 December 2020, and its financial performance for the year then ended in accordance with the Act on Accounting No. 431/2002 Coll. as amended (the "Act on Accounting").

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Entity in accordance with the provisions of Act No. 423/2015 Coll. on Statutory Audit and on Amendment to and Supplementation of Act No. 431/2002 Coll. on Accounting, as amended (hereinafter the "Act on Statutory Audit") related to ethical requirements, including the Code of Ethics for Auditors that are relevant to our audit of the financial statements, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management

Management is responsible for the preparation of the financial statements to give a true and fair view in accordance with the Act on Accounting, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.
